USE AND DOSE

Infurrow or 2 x 2 Application: Adjust for row spacing. Use 12 oz to 44 oz per acre. Prefer minimum of 8-10 gallons of solution per acre.

Banded Foliar Application: Mix 12 ounces to 2.0 lb per acre in amount of spray solution. Use of Y drop nozzles, will get the solution as close to the root system, as possible, for the best result.

Backpack Drenching: Use 1.0 oz. to 3.0 ounces per gallon. Use enough water to thoroughly soak the ground.

Broadcast application: Mix 1.0 lb or 3.0 lb per acre in amount of spray solution.

Fertigation: Mix 2.0 to 4.0 lb per acre thru drip or overhead irrigation equipment.

EcoVam GXT SP 200 should be mixed in water before mixing with other elements

Use enough water in spray solution to soak in the top 0.5 to 1 inch of soil or apply up to 0.50 inch of irrigation water to the field, if needed after application.
